The shares vesting were awarded as restricted performance shares in February 2015 as reported in the Form 4 filing on February 17, 2015. This filing states that 100% of the restricted performance shares will vest only upon the Company's return on invested capital being (1) in the top decile of the Company's peers as published by Bloomberg upon the close of the NYSE market on the last day of the Performance Period. The performance criteria and all requirements for vesting have been met and thus the shares fully vested on December 29, 2017, at the conclusion of the performance period.
