#### ITEM 5. Other Events.

On January 28, 2003, Tenet Healthcare Corporation (the "Company") completed an offering of \$1,000,000,000 aggregate principal amount of its 7<sup>3</sup>/<sub>8</sub>% Senior Notes due 2013 pursuant to its existing \$2,000,000,000 shelf registration statement. The offering was led by Salomon Smith Barney Inc., Banc of America Securities LLC and J.P. Morgan Securities Inc. The terms and conditions of the underwriting are set forth in the Pricing Agreement dated as of January 23, 2003, filed as Exhibit 4.1 hereto.

The terms and conditions of the notes are set forth in the Indenture dated as of November 6, 2001, between the Company and The Bank of New York, as trustee, filed as Exhibit 4.2 hereto, and the Sixth Supplemental Indenture, dated as of January 28, 2003, between the Company and The Bank of New York, as trustee, filed as Exhibit 4.3 hereto.
