Information with respect to each of OIML and OAML (collectively, the "Reporting Persons") is given solely by each such Reporting Person and no

Reporting Person has responsibility for the accuracy or completeness of information supplied by the other Reporting Person. OIML is the beneficial owner of 19,779,651 ordinary shares (represented by 9,027,595 ordinary shares and 10,752,056 American Depository Shares) or 4.96% of the 398,677,504 ordinary shares of Harmony Gold Mining Company Limited believed to be outstanding. OIML disclaims beneficial ownership of the 177,754 ordinary shares beneficially owned by OAML.

OAML is the beneficial owner of 177,754 ordinary shares (represented by 137,200 ordinary shares and 40,554 American Depository Shares) or 0.05% of the 398,677,504 ordinary shares of Harmony Gold Mining Company Limited believed to be outstanding. OAML disclaims beneficial ownership of the 19,779,651 ordinary shares beneficially owned by OIML.
