(1) This DSU was granted pursuant to Red Hat's 2006 Non-employee Director Compensation Plan, in lieu of a stock option grant, and vests over a one year period in 25% increments starting on the first day of each three month period following the date of the grant. The DSU will be paid out in cash or common stock at the election of Red Hat, Inc. on the earlier of September 1, 2010 (the deferral date designated by the Reporting Person) or upon termination of the Reporting Person's Board of Director service.

(2) This DSU is payable in either cash or common stock at the election of Red Hat, Inc.
