- Based on the Company's cash EPS growth in 2010, 107% of the original award of 23,632 performance-based restricted stock units granted 2/22/10 were earned, resulting in an additional 1,653 units, for a total of 25,285 units. The restrictions will lapse with respect to 8,428 units on 2/22/12 and with respect to 8,429 units on 2/22/13, subject to continued employment by the Reporting Person on the remaining vesting dates.
- Shares withheld by the Company to satisfy the Reporting Person's tax withholding obligation upon the vesting of restricted stock units.
