Health Net, Inc. (f/k/a Foundation Health Systems, Inc.) sold 132,910 of those shares of Common Stock on August 15, 2003. Immediately following such sale and as of the date hereof, Health Net, Inc. beneficially owned 2,519,094 shares of Common Stock.
