On November 16, 2005, Inamed Corporation ( Inamed ) issued a press release announcing that it had received a preliminary non-binding proposal from Allergan, Inc. ( Allergan ) to acquire all of Inamed 's outstanding shares in a transaction providing Inamed stockholders with a per share consideration of \$84.00 in cash or 0.8498 of a share of Allergan common stock. The proposal was communicated on November 14, 2005 in a letter from David E.I. Pyott, Allergan 's Chairman of the Board, President and Chief Executive Officer to Nicholas L. Teti, Inamed 's Chairman of the Board, President and Chief Executive Officer.
