As reported in a press release filed with the Securities and Exchange Commission as an exhibit to the Company's Report on Form 8-K dated May 16, 2006, the Company's wholly owned subsidiary, JDL Technologies Inc. (JDL) has been asked by an agency of the federal government to provide information related to a civil investigation regarding allegations that JDL submitted, or caused to be submitted, false claims for payment under the FCC's E-Rate Program in connection with funding requests made by the U.S. Virgin Islands Department of Education (VIDOE). In addition, two reviews of all transactions between JDL and VIDOE, one by management and the other by the Company's Audit Committee, have been initiated. The Company's Audit Committee determined that additional consideration of these developments should be reflected in the Form 10-Q Report; however, this could not be achieved by May 15, 2006.
