**MTS announces subscriber growth numbers for February 2008**

**Moscow, Russian Federation Mobile TeleSystems OJSC ( MTS NYSE: MBT), the largest mobile phone operator in Russia and the CIS, announces that its consolidated subscriber base reached 83.88 million users on February 29, 2008.**

During February 2008, MTS consolidated subscriber base increased by 0.93 million subscribers.
