(1) These securities, as represented in Columns 4 and 5, represent (a) 696 restricted shares issued in lieu of 50% of the annual cash retainer at the Company's annual meeting of its shareholders on June 11, 2013 (the "2013 Meeting"), which shares are immediately vested, and (b) 2,925 restricted shares acquired by a grant of the Board of Directors of the Company at the 2013 Meeting, which shares will vest in full on the first anniversary of the grant date.

(2) These securities, as represented in Column 5, were acquired by a grant of 7,335 shares by the Board of Directors of the Company at the 2013 Meeting. That grant vests in full on the first anniversary of the grant date or immediately (x) upon a change in control or a hostile takeover of the Company or (y) the death or permanent disability of the grantee if still serving at that time.
