Item 1. Security and Issuer.

This Amendment No. 8 amends and supplements the information set forth in the Schedule 13D filed by the Reporting Persons (as defined therein) with the United States Securities and Exchange Commission (the SEC) on February 28, 2011, as amended by Amendment No.1 filed on February 24, 2014, Amendment No. 2 filed on March 21, 2014, Amendment No. 3 filed on April 9, 2014, Amendment No. 4 filed on March 27, 2015, Amendment No. 5 filed on April 2, 2015, Amendment No. 6 filed on June 8, 2015, and Amendment No. 7 filed on June 11, 2015 (the Schedule 13D) relating to the shares of common stock, no par value per share (the Common Shares), of Central Pacific Financial Corp., a Hawaii corporation and a bank holding company (CPF) registered under the Bank Holding Company Act of 1956, as amended (BHC Act), whose principal executive offices are located at 220 South King Street, Honolulu, Hawaii 96813. All capitalized terms contained herein but not otherwise defined shall have the meanings ascribed to such terms in the Schedule 13D.

The information set forth in response to each separate Item below shall be deemed to be a response to all Items where such information is relevant. The Schedule 13D is hereby amended as follows:

Item 4. Purpose of Transaction.

Item 4 of the Schedule 13D is hereby amended and supplemented as follows:

On August 3, 2015, ACMO entered into an underwriting agreement (the August 3 Underwriting Agreement) with Citigroup Global Markets Inc. and UBS Securities LLC, as underwriters (the Underwriters), CPF and Carlyle. Pursuant to the August 3 Underwriting Agreement, each of ACMO and Carlyle has agreed, subject to the closing conditions contained therein, to sell to the Underwriters 2,769,312 Common Shares for a total of 5,538,624 Common Shares at a price of \$22.11 per Common Share.

In addition, the August 3 Underwriting Agreement provides that, during the period beginning on and including August 3, 2015 and continuing through and including the date that is 45 days after August 3, 2015, ACMO and Carlyle will not sell, offer, agree to sell, contract to sell, hypothecate, pledge, grant any option to purchase, make any short sale of or otherwise dispose of or hedge, directly or indirectly, any Common Shares, any securities of CPF substantially similar to any Common Shares or any securities convertible into, exchangeable or exercisable for, or that represent the right to receive any Common Shares or any securities of CPF substantially similar to any Common Shares, whether now owned or hereafter acquired, owned directly by ACMO or Carlyle or with respect to which ACMO or Carlyle now or hereafter has or may be deemed to have beneficial ownership in accordance with the rules and regulations of the SEC, without prior consent of the Underwriters, subject to customary exceptions. In addition, prior to the execution and delivery of the August 3 Underwriting Agreement, CPF obtained and delivered to the Underwriters executed lock-up agreements from certain directors and executive officers.

The description of the August 3 Underwriting Agreement set forth in this Item 4 does not purport to be complete and is qualified in its entirety by reference to the full text of the August 3 Underwriting Agreement filed as Exhibit 1.2 to this Amendment No. 8 and incorporated by reference herein.

Except as amended and supplemented hereby, Item 4 remains unchanged in all other respects.

Item 5. Interests in Securities of CPF.

Item 5 of the Schedule 13D is hereby amended and supplemented as follows:
