## Tendering Procedure for Petrobras Mature Fields

---

(Rio de Janeiro, February 14, 2003). PETROLEO BRASILEIRO S.A Petrobras, (BOVESPA: PETR3 / PETR4, NYSE: PBR / PBRA, LATIBEX: XPBR / XPBRA), Brazil's largest oil and gas, petrochemicals and energy company, announces that the public submission of bids for tender E&P-CORP No 001/2002, which is for the total assignment of exploration, development and production rights for oil and natural gas with the associated assets for the groups of fields BA2A, BA3A, BA4, BA5, BA6 and SE1A, scheduled for February 18, 2003, has been postponed to April 8, 2003.

This postponement arises from the need to study the effect on minimum prices of the new criterion for total assignment of rights over mature fields recently defined by the ANP.

In due course PETROBRAS will advise the participating companies as to whether there is any need to alter the tender prospectus, particularly with respect to the minimum prices that have been published.
