("FCM") of which 20,501,100 shares of Common Stock are owned by The Fairholme Fund and 7,982,400 shares of Common Stock are owned by Fairholme Allocation Fund, each a series of Fairholme Funds, Inc. Because Mr. Berkowitz, in his capacity as the Managing Member of FCM or as President of Fairholme Funds, Inc., has voting or dispositive power over all shares beneficially owned by FCM, he is deemed to have beneficial ownership of all such shares so reported herein.
