These holdings have been trued up to conform to the RSP balance as of 01/04/2010, and reflect the acquisition of approximately 2.46 shares on 4/15/2009, 3.61 shares on 7/15/2009, and 4.06 shares on 10/15/2009 due to dividend reinvestment.
