The RSUs will be forfeited if the Reporting Person's service as a Trustee terminates for cause.
- (2) Reporting Person's deferred compensation under the NSTAR Trustee Deferred Plan, a non-qualified plan, that is nominally invested as common shares. Each phantom share represents the right to receive the cash value of one NU common share upon a distribution event, following vesting.
