(1) The reporting person's holdings include 329.23 shares acquired under the issuer's dividend reinvestment and common stock purchase plan since the reporting person's last report. These shares were acquired pursuant to the employee stock purchase plan provisions of the dividend reinvestment and common stock purchase plan, which acquisitions are exempt from Section 16.

(2) Includes 171.49 shares acquired via dividend reinvestment on December 28, 2012 at \$30.28 per share.

(3) The reporting person's holdings include 144.46 shares acquired under the issuer's dividend reinvestment and common stock purchase plan since the reporting person's last report. These shares were acquired pursuant to the employee stock purchase plan provisions of the dividend reinvestment and common stock purchase plan, which acquisitions are exempt from Section 16.

(4) Includes 153.93 shares acquired via dividend reinvestment on April 2, 2013 at \$34.24 per share.

The stock account balance reflected in this report is based on a May 3, 2013, stock fund price of \$34.89 per share, and includes a company match of 353.440 phantom stock units acquired on February 14, 2013 at \$31.83 per unit.
