Restricted shares were granted under the Valley National Bancorp 2009 Long Term Incentive Stock Plan totaling 12,601 shares. Of the total shares, 5,041 shares (1) are time-based with three-year equal vesting beginning at grant date. The remaining 7,560 shares are subject to performance-based vesting conditions over a three-year performance period, all of which may be forfeited in the event performance conditions are not satisfied.
