- (1) The sale reported in this Form 4 was effected pursuant to a Rule 10b5-1 trading plan adopted by the reporting person on May 18, 2018. The total amount of securities reported as indirectly owned by the reporting person represents a reduction of .2645 shares allocated to the reporting person's account in the Company's 401(k) Plan ("Plan") as of July 31, 2018. To manage liquidity needs of the Plan, the Plan trustee from time-to-time maintains a lower overall share balance (versus cash) in the Plan, which in this instance resulted in a reduction in the number of shares allocated to the reporting person's account when compared to the reporting person's Form 4 filed on July 23, 2018.
