The number of shares that will actually vest each year will be based upon performance against certain financial goals for the Company, and will range from 0% to 200% of the target number of shares.

- (4) 427 shares are being surrendered as allowed by the Company's 2014 Stock Incentive Plan to cover payment of taxes currently due on previously granted restricted shares.

- (5) This stock appreciation right becomes exercisable in three equal annual installments beginning on the first anniversary of the grant date.
