(1) On February 17, 2016 the Issuer granted the Reporting Person a Restricted Stock Award (RSA) of 28,169 restricted shares of First Midwest Bancorp, Inc. Common Stock under the First Midwest Bancorp, Inc. Omnibus Stock and Incentive Plan which were scheduled to vest in two equal annual installments on the second and third anniversary of the date of grant. On February 17, 2019, the remaining 14,085 shares of the originally granted RSAs vested, of which 6,293 shares were surrendered by the Reporting Person in order to satisfy tax withholding obligations. This form is being filed to reflect the surrender of such shares to satisfy the Reporting Person's tax withholding obligation.

(2) Between January 10, 2018 and January 8, 2019, the Reporting Person acquired 182 shares of First Midwest Bancorp, Inc. Common Stock under the First Midwest Bancorp, Inc. Non-qualified Stock Option Gain Deferral Plan ("Plan") pursuant to the dividend reinvestment feature of the Plan. This information is based on a Plan statement dated January 8, 2019.
