**Oncolytics Biotech Inc. Announces Issuance of Fourth Canadian Patent  
Method of Extracting Virus from Cell Culture**

**CALGARY, AB January 26, 2006** - Oncolytics Biotech Inc. (TSX: ONC, NASDAQ: ONCY) (Oncolytics) has been granted Canadian Patent 2,437,962 entitled Method of Extracting Virus from Cell Culture. The claims describe methods of producing and extracting infectious reovirus from a culture of cells.

The claims in this Canadian patent broaden the intellectual property coverage for our manufacturing process, said Dr. Matt Coffey, Chief Scientific Officer for Oncolytics. The Company's patent portfolio now includes 13 U.S. patents, four Canadian patents and two European patents.
