Cameco Pursues Uranium Partnership with Russian Company

Saskatoon, Saskatchewan, Canada, November 22, 2006

Cameco Corporation announced today that it has signed a non-binding memorandum of understanding with Joint Stock Company Technobexport (Tenex), a leading state-owned, Russian nuclear company, to pursue future joint ventures in uranium exploration, development and production.

Tenex and Cameco will have further discussions to finalize an agreement that will enable the two companies to jointly explore for uranium in Russia, Canada and other prospective jurisdictions, and, if warranted, engage in development and production of uranium deposits that are found.

Cameco anticipates that a selection of joint exploration projects will be made, and a binding agreement signed, in 2007.

Cameco has worked with Tenex for a number of years and currently has an agreement with them to purchase uranium from dismantled Russian weapons.

Tenex, with its head office in Moscow, Russia, is involved with a wide range of nuclear fuel cycle products and services.

Cameco, with its head office in Saskatoon, Saskatchewan, is the world's largest uranium producer. The company's uranium products are used to generate electricity in nuclear energy plants around the world, providing one of the cleanest sources of energy available today. Cameco's shares trade on the Toronto and New York stock exchanges. deterioration in political support for nuclear energy; changes in government regulations and policies, including tax and trade laws and policies; demand for nuclear power; replacement of production; failure to obtain or maintain necessary permits and approvals from government authorities; legislative and regulatory initiatives regarding deregulation, regulation or restructuring of the electric utility industry in Ontario; Ontario electricity rate regulations; natural phenomena including inclement weather conditions, fire, flood, underground floods, earthquakes, pit wall failure and cave-ins; ability to maintain and further improve positive labour relations; strikes or lockouts; operating performance, disruption in the operation of, and life of the company's and customers' facilities; decrease in electrical production due to planned outages extending beyond their scheduled periods or unplanned outages; success of planned development projects; and other development and operating risks.
