**CALGARY, March 22, 2004** Fording Canadian Coal Trust (TSX: FDG.UN, NYSE: FDG) today announced that it has filed its audited consolidated financial statements for the year ended December 31, 2003 and related management's discussion and analysis and its annual information form with Canadian security regulatory authorities. The financial statements and management's discussion and analysis and the Trust's form 40-F have also been filed with the United States Securities and Exchange Commission. Elk Valley Coal, comprised of Canada's senior metallurgical coal mining properties, is the world's second largest exporter of metallurgical coal, capable of supplying approximately 25 million tonnes of high-quality coal products annually to the international steel industry.
