A total of 7,000 shares were sold pursuant to a 10b5-1 Plan, at an average sale price of \$7.11466 per share. The actual sale price for the (1) shares was: 200 shares at \$7.15; 400 shares at \$7.155; 100 shares at \$7.17; 300 shares at \$7.1575; 800 shares at \$7.18; 100 shares at \$7.16; 200 shares at \$7.105; 1,507 shares at \$7.10; 300 shares at \$7.11; 1,293 shares at \$7.19; and 1,800 shares at \$7.02.

The options are exercisable as they vest. A total of 25% of the entire number of shares subject to this stock option becomes vested and (2) fully exercisable on the first anniversary of the vesting commencement date and the remaining shares subject to this stock option vest and become exercisable in equal monthly installments, ratably over the following 36 months.
