- (2) A total of 12,500 shares were sold pursuant to a 10b5-1 Plan, at an average sale price of \$6.2637 per share. The actual sale price for the shares was: 500 shares at \$6.22; 500 shares at \$6.23; 400 shares at \$6.2325; 1,400 shares at \$6.24; 500 shares at \$6.2425; 200 shares at \$6.245; 3,400 shares at \$6.25; 1,000 shares at \$6.26; 1,533 shares at \$6.27; 167 shares at \$6.28; 200 shares at \$6.29; 977 shares at \$6.30; 1,323 shares at \$6.31; and 400 shares at \$6.35.
- (3) The options are exercisable as they vest. A total of 25% of the entire number of shares subject to this stock option becomes vested and fully exercisable on the first anniversary of the vesting commencement date and the remaining shares subject to this stock option vest and become exercisable in equal monthly installments, ratably over the following 36 months.
