(1) On January 2, 2008, the Issuer entered into an agreement with George J. Vojta (the "Reporting Person") whereby the Reporting Person was granted a restricted stock award of 900 shares of Class A Common Stock pursuant to the Issuer's Amended and Restated Restricted Stock Award Plan (the "Restricted Stock Award Plan").

(2) This figure includes 3,800 restricted shares of Class A Common Stock issued pursuant to the Restricted Stock Award Plan. On January 2, 2008, restrictions applicable to a previously reported grant of 250 shares each of Class A Common Stock and Common Stock lapsed, resulting in the Reporting Person becoming fully vested in such shares. This resulted in no change in the number of shares beneficially owned by the Reporting Person.
