 - (1) Shares of restricted stock granted on May 5, 2010 under the issuer's Stock Incentive Plan, as amended and restated from time to time. The shares vest one-third on each of the next three regularly-scheduled annual meetings of the issuer's stockholders following the date of grant. The number of shares granted was determined by reference to the closing price per share of the issuer's common stock on the New York Stock Exchange on May 4, 2010 of \$24.20.
 - (2) The net decrease in the number of shares reported since the last Form 4 filed reflects the (i) acquisition which this Form 4 reports and (ii) distribution by ACON E&P, LLC (the "LLC") to ultimate beneficial owners of 100% of the 184,044 shares previously reported as beneficially owned by the LLC, including 31,600 shares distributed to Mr. Aronson, which he now owns directly. Mr. Aronson disclaimed beneficial ownership of the securities held by the LLC except to the extent of his pecuniary interest therein.
