Other Events.

On Feb. 8, 2011, Public Service Company of Colorado (PSCo) a Colorado Corporation and a wholly owned subsidiary of Xcel Energy Inc., filed a request with the Federal Energy Regulatory Commission (FERC) to change Colorado wholesale electric customer rates to formula based rates with an expected increase of \$16.1 million annually for 2011. PSCo is seeking to make the request effective in April 2011; however, the FERC has the authority to grant a five month suspension from the April date. The request was based on a 2011 forecast test year, a 10.90 percent return on equity (ROE), a total PSCO wholesale production rate base of \$407 million and an equity ratio of 57.10 percent. The formula rate will be estimated each year for the following year and then will be trued up to actual costs after the conclusion of the calendar year. The primary drivers of the revenue deficiency are the inclusion of the recently acquired Blue Spruce Energy Center and Rocky Mountain Energy Center generating units and inclusion of the costs of early retirement of certain coal plants under the Clean Air Clean Jobs Act emissions reduction plan, all of which were approved by the Colorado Public Utility Commission in late 2010.
