(1) Pursuant to an Exchange Agreement, dated as of September 27, 2012, among Ralcorp Holdings, Inc. ("Ralcorp") and certain investment banks party thereto, Ralcorp exchanged 5,450,000 shares of common stock of Post Holdings, Inc. (the "Issuer") with certain debt holders of Ralcorp in satisfaction of approximately \$166.2 million of outstanding debt of Ralcorp, reflecting consideration of \$30.50 per share. On October 3, 2012, Ralcorp plans to exchange its remaining shares of common stock of the Issuer with certain debt holders of Ralcorp.
