- (1) Shares acquired in payment of director retainer and meeting fees.
- Warburg Pincus Private Equity X, L.P., a Delaware limited partnership (together with an affiliated limited partnership, "WP X") is the holder of (a) 46,159,252 shares of Common Stock and (b) warrants exercisable for 25,919,391 shares of Common Stock. Warrant balance reflects anti-dilution adjustment. See note 6.
- (3) Warburg Pincus X L.P., a Delaware limited partnership ("WP X LP") is the general partner of WP X; Warburg Pincus X LLC, a Delaware limited liability company ("WP X LLC") is the general partner of WP X LP; Warburg Pincus Partners LLC, a New York limited liability company ("WP Partners") is the sole member of WP X LLC; Warburg Pincus & Co., a New York general partnership ("WP") is the managing member of WP Partners; Warburg Pincus LLC, a New York limited liability company ("WP LLC") manages WP X; and Messrs. Charles R. Kaye and Joseph P. Landy, each a Managing General Partner of WP and Managing Member and Co-President of WP LLC, who may be deemed to control the Warburg Pincus entities.
- (4) Pursuant to Rule 16a-1(a)(4) of the Securities Exchange Act of 1934, as amended, (the "Act") each of WP X LP, WP X LLC, WP Partners, WP, WP LLC, and Messrs. (6) MBIA Inc.'s issuance of warrants to Blue Ridge Investment, L.L.C., which was consummated on May 6, 2013, triggered certain anti-dilution adjustments under the terms of WP X's previously reported warrants that were previously exercisable for 25,327,646 shares of Common Stock. This anti-dilution adjustment is being voluntarily reported; no transaction has taken place with respect to these warrants.
