Excess Benefit and Deferred Compensation Plan of 2005 (the "Compensation Plan Trust") purchased 524 shares of Common Stock for the benefit of Willing L. Biddle, the Reporting Person's husband and an officer and a director of the Issuer, at a weighted average price of \$17.4344 per share.
