Mr. Chaimovski has no voting or dispositive power over the shares held by Argyle Joint Venture. Although Argyle Joint Venture owns 278,910 shares and options to purchase 34,176 shares, Mr. Chaimovski has a pecuniary interest in only 11,603 of such shares and 1,422 of such options to purchase shares.

(3) The reported securities are included within 31,250 units purchased by Mr. Chaimovski for \$8.00 per unit in a private placement. Each unit consists of one share of common stock and one warrant to purchase common stock.
