Effective September 30, 2007, Chemtura Corporation entered into an amendment No. 1 dated as of September 30, 2007 to the Amended and Restated Credit Agreement dated as of July 31, 2007 ("Credit Agreement"), with its lenders that amended Section 5.03(b) (Interest Coverage Ratio) by changing the required ratio of Consolidated EBITDA of the Company and its subsidiaries to Interest Expense of the Company and its subsidiaries on September 30, 2007 and December 31, 2007 from 4.50:1.00 to 4.25:1.00.
