(a) Name of Person Filing: This joint statement on Schedule 13G is being filed by Peter Kolchinsky, RA Capital Management, LLC, and RA Capital Healthcare Fund, L.P., who are collectively referred to herein as the "Reporting Persons." Mr. Kolchinsky (the "Manager") is the manager of RA Capital Management, LLC ("Capital"), which is the investment adviser and sole general partner of RA Capital Healthcare Fund, L.P. ("Fund") and serves as the investment adviser to a separate discretionary account. The Reporting Persons have entered into a Joint Filing Agreement, dated as of the date hereof, a copy of which is filed with this Schedule 13G as Exhibit 1 (which is incorporated herein by reference), pursuant to which the Reporting Persons have agreed to file this statement jointly in accordance with the provisions of Rule 13d-1(k) under the Act.

As of the date of this filing, the Reporting Persons, in the aggregate, beneficially own 5,285,000 shares of the Common Stock of the Issuer, representing approximately 6.5% of such class of securities. The beneficial ownership of each Reporting Person is as follows: (i) Fund beneficially owns 3,540,150 shares of Common Stock representing approximately 4.3% of the class and (ii) Capital, as the investment adviser and sole general partner of the Fund and investment adviser to an account owned by a separate investment vehicle which holds shares of the Issuer's Common Stock, and Mr. Kolchinsky as the manager of Capital, each beneficially own 5,285,000 shares of Common Stock of the Issuer representing approximately 6.5% of the class. The percentage of Common Stock beneficially owned by each Reporting Person is based on a total of 81,394,901 shares of Common Stock of the Issuer outstanding as reported on Issuer's Form 10-Q filed with the SEC on November 08, 2012 and the Issuer's Form 8-K filed with the SEC on February 05, 2013.
