Stock Plan. The restricted stock was not vested on the date of grant. 87,500 of the shares vest 50% on July 2, 2007, 25% on January 2, 2008 and 25% on July 1, 2008. The remaining 22,500 shares vest one-third (1/3) on each of November 16, 2007, November 16, 2008 and November 16, 2009.
