## Item 7.01. Regulation FD Disclosure

On January 24, 2008, Global Partners LP (the "Partnership") issued a press release announcing that the Board of Directors of its general partner, Global GP LLC, declared a quarterly cash distribution of \$0.4875 per unit (\$1.95 per unit on an annualized basis) on all of its outstanding common and subordinated units for the period from October 1, 2007 through December 31, 2007. On February 14, 2008, the Partnership will pay such cash distribution to its common and subordinated unitholders of record as of the close of business February 5, 2008. This distribution represents increases of approximately 7.1% over the quarterly distribution of \$0.4550 paid in February 2007 and 1.6% over the quarterly distribution of \$0.4800 paid in November 2007. A copy of the press release is attached hereto as Exhibit 99.1 and incorporated herein in its entirety.
