The remaining 325 restricted stock units become fully vested and non-forfeitable on July 28, 2011, if reporting person remains a director of issuer.

The remaining 650 restricted stock units become fully vested and non-forfeitable 50% on July 27, 2011 and 50% on July 27, 2012, if reporting person remains a director of issuer.
