On September 4, 2014, Consolidated Communications Holdings, Inc. (the "Company") issued a press release announcing that its wholly owned subsidiary, Consolidated Communications Finance II Co., intends to offer, subject to market and other conditions, \$200 million aggregate principal amount of senior notes due 2022.
