having to consult with any other person. The Hancock Member is party to an agreement pursuant to which it has the right to independently make decisions as to voting and disposition of 318,552 of the Ordinary Shares held by Hancock, without having to consult with any other person. Mr. Jaglom disclaims beneficial ownership of all of the Ordinary Shares that may be deemed to be beneficially owned by him except to the extent of his pecuniary interest therein.

Samson Capital, which (as of December 31, 2016) beneficially owns less than 5% of the issued and outstanding Ordinary Shares, is reporting its beneficial ownership in a separate Statement of Beneficial Ownership on Schedule 13G (as amended) that it is filing jointly with another reporting person.

Similarly, the shareholders of the company that holds 61.2% of the membership interests of Hancock (for which Elchanan Jaglom serves as a director) have the right to receive a portion of the dividends from, and proceeds from the sale of, the 357,338 Ordinary Shares held by Hancock.
