(1) Twenty-five percent (25%) of the shares subject to the option shall vest in four equal quarterly installments commencing on June 30, 2009.

(2) The reporting person received an option with respect to 8,489 shares of CardioNet, Inc. (the "Company") common stock pursuant to the CardioNet, Inc. 2008 Equity Incentive Plan (the "Plan") in lieu of payment to the reporting person of an annual retainer fee of \$50,000 for serving as a member of the Board of Directors. As provided in the Plan, the option covers a number of shares of the Company's common stock equal to 300% of the amount of the retainer divided by the closing price of the Company's common stock on May 8, 2009 (the grant date), at an exercise price per share equal to the closing price of the Company's common stock on the grant date.
