- (1) As provided in the Issuer's Amended and Restated Certificate of Incorporation, each share of Class B Common Stock is convertible at any time, at the option of the holder, into one share of Class A Common Stock. In addition, each share of Class B Common Stock will convert automatically into one share of Class A Common Stock upon any transfer, whether or not for value, except for certain permitted transfers described in the Issuer's Amended and Restated Certificate of Incorporation.
- (2) The sole member of the Reporting Person is F.L.P. Trust #14M2, a trust for the benefit of Gigi Pritzker Pucker. Edward W. Rabin and Gigi Pritzker Pucker serve as co-trustees of F.L.P. Trust #14M2 and have shared voting and investment power over the shares beneficially owned by the Reporting Person. The acquisition of shares of Class B Common Stock by the Reporting Person constitutes a "permitted transfer" as defined under the Issuer's Amended and Restated Certificate of Incorporation. Contemporaneous with such acquisition of shares, the Reporting Person executed joinders to, and thereby became subject to the provisions of, the Amended and Restated Global Hyatt Agreement, the Amended and Restated Foreign Global Hyatt Agreement and the Amended and Restated Agreement Relating to Stock. Accordingly, immediately following the acquisition of shares, the shares remain shares of Class B Common Stock.
