- On 5/26/2006 the reporting person was granted a restricted stock award of 29,553 shares that became eligible to vest, pending the achievement of certain performance criteria, in four equal annual installments beginning on March 1, 2007. As of April 26, 2012 the (1) performance criteria (investment returns to investment funds affiliated with Bain Capital Partners, LLC, The Carlyle Group and Thomas H. Lee Partners, L.P.) as to 58.9% of the award was achieved, resulting in incremental vesting of this award as to 8,900 shares. In total, as of April 26, 2012, an aggregate of 17,406 shares subject to this award have vested.
