- (1) Sale was made pursuant to a trading plan under Rule 10b5-1 under the Securities and Exchange Act of 1934, as amended, which was adopted on November 8, 2012 for estate planning and diversification purposes.  
  
The price reported in Column 4 is a weighted average price. The Common Stock was sold at prices ranging from \$2.74 to \$2.875. - (4) The option, originally representing a right to purchase a total of 195,510 shares, vests in equal annual installments on the first through fourth anniversaries of April 1, 2010. As of June 17, 2013, 48,878 shares remain subject to vesting.
