United Community Banks, Inc. (the “Company”) files this Registration Statement on Form S-8 in connection with the United Community Banks, Inc. Profit Sharing Plan (the “Plan”) to increase the number of shares of common stock that may be issued under the Plan. The shares authorized under the Plan have been increased by 500,000. The company previously filed a registration statement on Form S-8 (File No. 333-86876) (the “Initial Registration Statement”) covering 300,000 shares (or 200,000 shares adjusted for a 3 for 2 stock dividend) of the Company’s common stock initially authorized for issuance under the Plan. The Initial Registration Statement continues and remains effective as to those shares registered thereunder.
