- (1) In 1999 Mr. Poe contributed Semtech common stock to an exchange fund in exchange for shares of the exchange fund. He has only recently become aware that a Form 4 filing was required for this transaction. According to records now available, the Semtech common stock was valued at approximately \$71.44 per share for the purpose of determining the number of shares of the exchange fund issued to Mr. Poe.
 - (2) Total of direct and indirect ownership as of the transaction date. These shares included 46,880 shares held by Mr. Poe's children.
 - (3) As of the date of this report, Mr. Poe directly and indirectly holds (on a split-adjusted basis) 1,582,532 shares, including 187,520 shares held by his children. He disclaims beneficial ownership of 125,008 of these shares held by adult children.
