ChipMOS TECHNOLOGIES ANNOUNCES PROPOSED OFFERING OF

CONVERTIBLE SENIOR NOTES

Hsinchu, Taiwan, October 27, 2004 ChipMOS TECHNOLOGIES (Bermuda) LTD. (ChipMOS or the Company) (Nasdaq: IMOS) today announced its intention to offer approximately US\$50 million (or US\$62.5 million including the bookrunner's option to increase) in convertible senior notes due 2009, subject to entering into a purchase agreement with the initial purchasers and subject to market and other conditions.
