On May 13, 2005, AmerisourceBergen Corporation (the Registrant) issued a news release announcing that the Registrant's Board of Directors has authorized the Registrant to repurchase up to \$450 million of its outstanding shares of common stock subject to market conditions. The Registrant will repurchase the shares from time to time for cash in open market transactions in accordance with applicable federal securities laws and in accordance with the terms of the Registrant's debt instruments. The Registrant also indicated, among other things, that its expectations for fiscal 2005 remain unchanged, including expected operating revenue in fiscal 2005 of about \$49 billion. A copy of the news release is filed as Exhibit 99.1 to this report and incorporated herein by reference.
