Item 8.01 Other Events

On July 7, 2005, C&F Financial Corporation issued a news release announcing the amendment of its tender offer to increase the number of shares of its common stock the company is willing to repurchase to up to 450,000 shares from the original amount of up to 180,000 shares. The increase in the tender offer will cost an additional \$11,070,000, bringing the total cost to \$18,450,000, rather than \$7,380,000 for the original repurchase amount. The company expects to fund the increase with a \$10,000,000 issuance of trust preferred securities. A copy of the company s news release is attached as Exhibit 99.1 to this Current Report on Form 8-K and is incorporated herein by reference into this Item 8.01.
