**Hsinchu, Taiwan, June 15, 2006** ChipMOS TECHNOLOGIES (Bermuda) LTD. ( ChipMOS or the Company ) (Nasdaq: IMOS) today reported its unaudited consolidated revenue for the month of May 2006.

Revenue for the month of May 2006 was NT\$ 1,553.6 million or US\$48.5 million, a decrease of 2% from NT\$1,584.6 million or US\$49.5 million for the month of April 2006 and an increase of 21% from NT\$1,283.6 million or US\$40.1 million for the same period in 2005. (All translations from NT dollars to U.S. dollars were made at the exchange rate of NT\$32.025 against US\$1.00 as of May 30, 2006.)

ChipMOS May 2006 consolidated revenue included revenues of ChipMOS TECHNOLOGIES INC., ChipMOS Japan Inc., ChipMOS U.S.A., Inc., ChipMOS TECHNOLOGIES (H.K.) Limited, MODERN MIND TECHNOLOGY LIMITED and its wholly-owned subsidiary ChipMOS TECHNOLOGIES (Shanghai) LTD., and ThaiLin Semiconductor Corp.
