On **December 14, 2006**, Hercules Offshore, Inc. The Hercules Offshore Liftboat Fleet Status also includes the revenue per day for each liftboat class for the month of November 2005. This Fleet Status Report is furnished as Exhibit 99.1 to this Current Report on Form 8-K and is incorporated herein by reference.
